

## MENTER WŶN CFFI CYMRU

Partneriaeth rhwng Dunbia (Llanybydder), Sainsbury's a CFFI Cymru yw Menter Wŷn CFFI Cymru. Mae'r bartneriaeth yn rhoi cyfle i aelodau CFFI Cymru\*\* i gyflenwi eu cig oen Cymreig i siopau Cymreig Sainsbury am bris premiwm trwy gydol y flwyddyn.

Cytunai'r holl bartneriaid fod hyfforddiant yn hanfodol ac fel un o amodau'r cynllun, mae'n ofynnol i gyflenwyr i gymryd rhan mewn o leiaf dwy sesiwn hyfforddi bob blwyddyn. Mae'r holl hyfforddiant wedi ei deilwra i fod yn ymarferol ac i sicrhau fod cyflenwyr yn darparu'r wŷn gorau posibl. Bydd diwrnodau datblygu yn cael eu cynnal yn ogystal â hyfforddiant DPP (Datblygiad Proffesiynol Parhaus) mewn modiwlau megis Dewis Stoc, Tir Glas ac Iechyd Anifeiliaid.

- Naill ai'n unig fasnachwr, yn bartner llawn neu'n gweithio ar y daliad cartref gan ennill y rhan fwyaf o'u hincwm neu fudd-daliadau o'r busnes\*\*\*
- Yn gynhyrchydd neu'n besgwr
- Aelod 'Farm Assurance'
- Y Ffermwyr Ifanc fydd y prif gyswllt a bydd yn gyfrifol am gymryd rhan yn y rhaglen ddatblygu drwy fynychu o leiaf dau sesiwn hyfforddi'r flwyddyn

## WALES YFC LAMB INITIATIVE

The Wales YFC Lamb Initiative is a partnership between Dunbia (Llanybydder), Sainsbury's and Wales YFC. The partnership provides the opportunity for Wales YFC members\*\* to supply their Welsh lamb to Welsh Sainsbury's stores at a premium price all year round.

The aim of the scheme is to work with a forward thinking processor and retailer to attract Wales YFC members who produce lamb to become suppliers and to keep Young Farmers at the forefront of the industry. Ultimately the initiative is about creating a sustainable supply chain to help support the future of rural Wales.

### What are the benefits for suppliers?

Members of the scheme will receive a premium price for their lamb as well as a bonus payment of £1.00 per lamb for hitting the specification. Please see payment grid below for more details:

#### Overweights

Pay as per grid to 22kg & no conformation bonus

Each lamb that reaches the following specification will also qualify for the £1.00 per head bonus payment:  
Weight Specification: 15 – 22 kg

Acceptable fat class: 2 & 3L

Acceptable grade: E, U & R

Payments will be made by Dunbia (Llanybydder) via Bacs within 14 days.

All partners agree that training is vital and as a condition of the scheme, suppliers are required to take part in at least two training sessions per year. All training is tailored to be practical and to ensure that suppliers are providing the best lambs possible. There will be development days as well as training in modules such as Stock Selection, Grassland and Animal Health. We welcome members views on which training will be useful to them.

Welsh lamb produced by Wales YFC members will be on the shelves in the sixteen Welsh Sainsbury's stores.

You are in control. There are no contracts involved so you are free to supply to the scheme as little or as much as you choose.

## Technical Information

- Dunbia (Llanybydder) will supply a free fieldsman service to select and assist with livestock if required
- Dunbia (Llanybydder) will arrange haulage at a collection centers throughout Wales if required
- Dunbia (Llanybydder) have an open door policy and welcome members who wish to see their lambs being processed (Covid restrictions dependent)
- Weights and grades are available by e-mail evening of slaughter (Please ensure you inform procurement staff of any email address changes)
- Independent grading by MLCS Ltd
- Weights are taken to the nearest 0.1kg
- In total, the scheme is required to supply 400 lambs per week

### What's in it for YFC?

The scheme creates an income stream for the movement, as Sainsbury's directly contribute 40p per lamb sold (on top of the price that you receive) to Wales YFC. 10p of that goes directly to your County Federation.

### Who is eligible?

In order to supply to the Wales YFC Lamb Initiative, suppliers must meet the following criteria:\*

- A Wales YFC member or Associate member\*\*
- Young Farmer must be living in Wales, and the main holding must be in Wales
- Aged between 16 and 40 years old
- Either the sole trader, a full partner or working on the home holding gaining the majority of their income or benefits from the business\*\*\*
- A producer or a finisher
- Farm Assurance member
- The Young Farmer will be the main contact and will be responsible for participating in the development programme by attending at least two training sessions per year

\*Supporting documents will be required to prove that you adhere to the above supplier criteria.

\*\*If over 26 years of age, you can become an Associate Member by contacting the local County Office.

\*\*\*Due consideration will be given to special circumstances on an individually assessed basis.

### How do I become a supplier?

If you meet the criteria above and you would like to enter this scheme please complete the enclosed form and return it to the Wales YFC office. You must also include at least one supporting document as proof. (Accepted documents are listed on the enclosed form).

Once your details have been checked, you will receive confirmation of acceptance into the scheme and you are free to supply lambs. This can be done by contacting your local Dunbia procurement officer who will support you through the whole process.
